“Medication Safety and Documentation errors in Hospitals and Health care Organisations”

As per a study in United States, preventable medical errors are considered to be the third leading cause of death of patients.

Medication errors (including wrong drug, dose, patient, route of administration and documentation) are major causes of inpatient morbidity and mortality.

The purpose of complete and accurate patient record documentation is to foster quality and continuity of care. It creates a means of communication between providers and the consumers.

Documentation errors can lead to compromised health care delivery and endanger patient safety. Right Documentation is the essential part of patient care affecting all aspects of treatment.

About the Program: National Board for Quality Promotion (NBQP), a constituent Board of Quality Council of India (QCI), is conducting a One-day Programme on **“Medication Safety and Documentation errors in Hospitals and Health care Organisations”** for the benefit of industry, organizations, society and other stakeholders. This is an activity under **National Quality Campaign** being implemented by **Quality Council of India**.

Course Description: This programme is intended to impart awareness on medication safety and prevention of documentation errors in healthcare. Health services work incessantly to provide safe and high-quality care, but at times patients are inadvertently harmed. The objective of this course is to understand the concept of medication errors, identify factors that contribute to medication errors, understand the benefits of a multidisciplinary approach to medication safety, learn how to implement safe medication practices, perceive the concept of documentation errors, understand importance of data archiving, data security and confidentiality and ensure implementation of correct documentation process.
